

## Action to promote the retraining of retired racehorses

France Galop, *La Ligue de Protection du Cheval* (French Horse Protection League) and the *Au-Delà Des Pistes* (A.D.D.P.) charity need your help to enable former racehorses to enjoy a dignified and well-deserved retirement, sometimes for several decades.

As an owner, breeder, trainer or jockey, you can agree to automatically donate a portion of your race winnings to the fund: every time you win a race, 1/1000<sup>th</sup> (or more) of your winnings will automatically be transferred.

Please note: All donations are tax deductible!

Background history: In September 2007, France Galop and *La Ligue Française pour la Protection du Cheval* created the *Fonds de Reconversion des Chevaux de Course* (Racehorse Retraining Fund).

Its aim, which still applies today, was to give every owner the opportunity to give their horses a new life at the end of their racing career.

In 2017, France Galop approached the *Au-Delà Des Pistes* retrained racehorse charity to give this project, which concerns us all, an extra boost. We are now able to offer more retraining opportunities to a greater number of racehorses.

How does it work? France Galop has entrusted the A.D.D.P. charity to manage the horses that are coming out of training and whose owner wants them to enjoy a second career. Thanks to the network of experts involved in the charity, A.D.D.P. acts like a crossroads to guide these horses in a suitable direction.

There are several possible scenarios:

- *The horse is "healthy"*: It can be retrained for sport, polo, eventing, riding clubs or even as a leisure horse for a family that is able to provide stabling. The horse will require a settling-in period so that it can get used to its new lifestyle, which will be much calmer than its former life in training.
- *The horse presents a certain number of pathologies* preventing it from working: The aim is then to find somewhere for the horse to live with ample grazing, so that it can enjoy a permanent, well-deserved retirement. Thanks to *La Ligue Française de Protection du Cheval* and its network of expert volunteers spread all over France, these horses are regularly checked to monitor the quality of care provided.
